

CHAPTER 79.

[H. B. 39.]

RELATING TO BOARD OF VETERINARY EXAMINERS.

AN ACT relating to the practice of veterinary medicine, surgery and dentistry and amending sections 8437, 8438 and 8443 of Remington & Ballinger's Annotated Codes and Statutes of Washington.

Be it enacted by the Legislature of the State of Washington:

SECTION 1. That section 8437 of Remington & Ballinger's Annotated Codes and Statutes of Washington be amended to read as follows:

Section 8437. The board shall keep a register of all registered practitioners in the state setting forth such facts as the board may see fit. All money received or collected by said board or any member or officer thereof during any month shall be turned over before the 10th day of the succeeding month to the state treasurer together with a verified statement showing the sources from which such money was derived. The treasurer of said board shall give surety bond to be approved and deposited with the auditor of the state in the sum of \$1,000. The cost of said bond shall be paid by the state.

SEC. 2. That section 8438 of Remington & Ballinger's Annotated Codes and Statutes of Washington be amended to read as follows:

Section 8438. Each member of the board of veterinary medical examiners shall receive a compensation of five dollars per day for each day in which he is actually and necessarily engaged in attendance upon the meetings of the board and in going to and returning from the place of meeting and all necessary expenses incurred in attending such meetings. All such compensation and expenses and all other expenses incident to the execution of the provisions of this act shall be paid by the state treasurer upon warrants drawn by the state auditor upon the presentation of proper vouchers to be approved by a majority of said board as in the case of state officers. and treasurer of the board shall each receive a compensation to be determined by said board and not to exceed \$50 per annum.

SEC. 3. That section 8443 of Remington & Ballinger's Annotated Codes and Statutes of Washington be amended to read as follows:

Section 8443. The board shall render on or before January 1st of each year to the governor a concise statement or report of all matters pertaining to the duties imposed upon the board in this act and making such suggestions as they shall deem expedient and proper.

FIXING THE COMPENSATION OF BOARD OF DENTAL EXAMINERS.

AN ACT relating to the practice of dentistry and amending section 8423 of Remington & Ballinger's Annotated Codes and Statutes of Washington.

Be it enacted by the Legislature of the State of Washington:

SECTION 1. That section 8423 of Remington & Ballinger's Annotated Codes and Statutes of Washington be amended to read as follows: Section 8423: Each member of the board of dental examiners shall receive a compensation of five dollars a day for each day in which he is actually and necessarily engaged in attendance upon the meetings of the board, and in going to and returning from the place of meeting, and all necessary expenses incurred in attending such meetings; all such compensation and all other expenses incident to the execution of the provisions of this act shall be paid by the state treasurer upon warrants drawn by the state auditor upon the presentation of proper vouchers to be approved by a majority of said board as in the case of state officers. The secretary of said board shall receive a compensation to be determined
