The Governor has 5 days, excluding Sundays, to take action on any bill passed by the Legislature, provided adjournment does not occur within those 5 days.

— First day of session.

- * After the 54th day, only initiatives, alternatives to initiatives, budgets and matters necessary to implement budgets, messages pertaining to amendments, differences between the houses, and matters incident to the interim and closing of the session may be considered.

— Last day to read in committee reports in house of origin, except House fiscal committees and Senate Ways & Means and Transportation committees.

— Last day to read in committee reports from House fiscal committees and Senate Ways & Means and Transportation committees in house of origin.

— Last day to consider bills in house of origin (5 p.m.).

— Last day to read in committee reports from opposite house, except House fiscal committees and Senate Ways & Means and Transportation committees.

— Last day to read in opposite house committee reports from House fiscal committees and Senate Ways & Means and Transportation committees.

— Last day to consider opposite house bills (5 p.m.) (except initiatives and alternatives to initiatives, matters necessary to implement budgets, amendments, differences, and business related to the interim or closing the session).

— Last day allowed for regular session under state constitution.
