### Elk Management Update From the Department of Fish and Wildlife

The Agriculture and Natural Resources Committee (Committee) will invite the Department of Fish and Wildlife to provide an update on statewide elk management. (One work session)

### **Ecosystem Services Update From the Department of Natural Resources**

In 2023 the Legislature considered House Bill 1789, which would authorize the sale of credits from ecosystem services projects on state lands. Although the bill did not pass in 2023, \$83 million was provided in the 2023-25 Capital Budget for certain types of carbon sequestration projects on state lands, a facilitated workgroup, and related research and analysis. The Committee will invite the Department of Natural Resources to provide an update on activities undertaken with this funding. (One work session)

### Voluntary Riparian Buffer Grant Program Update

The Committee will invite the State Conservation Commission to provide an update on development and implementation of the voluntary riparian buffer program funded by the 2023-25 Capital Budget. (One work session)

# **Update on the Working Families Tax Credit**

Individuals and families may receive refunds of up to \$1,200 if they meet certain eligibility requirements under the Working Families Tax Credit (WFTC) program. The Department of Revenue (DOR) first began issuing refunds under this program in 2023. Both the payments and the administration of the WFTC are funded in the state operating budget.

The Appropriations Committee (Committee) will receive an update on how the WFTC is being implemented by the DOR. (One work session)

# Update on Transitioning Patients from Acute Care Hospitals to Community and Other Settings

The state operating budget funds numerous efforts designed to facilitate the transition of ready-to-discharge patients from acute care hospitals to more appropriate care settings.

The Committee will receive an update on how additional funding contained in the operating budget for transitioning ready-to-discharge patients is being implemented. (One work session)

#### Update on the Climate Commitment Act

The Climate Commitment Act (CCA) was enacted in 2021. The CCA capped emissions from certain covered entities, created an auction process to allow for the purchase of emission allowances, and directed that auction proceeds be used for certain programs, projects, and activities. The CCA requires that at least 35 percent of funds be invested in projects that benefit overburdened communities, and a minimum of 10 percent go to projects with tribal support.

The first auction took place in 2023. The CCA funds were appropriated in operating, capital, and transportation budgets during the 2023 legislative session.

The Committee will be provided a summary of CCA funding appropriated in the 2023 legislative session along with an update on CCA implementation including auction proceeds and use of funds. (One work session)

#### 2024 Session Budget Preview

The Committee will receive an update on the budget outlook after the September and November revenue forecasts and estimated maintenance level changes. The Committee will also receive a preview of budget related items that may come before the Legislature in the 2024 session. (One work session)

# Local Tax Financing Tools That Encourage Economic Growth

#### **Update on Capital Gains**

After the Washington Supreme Court upheld the tax on the sale of long-term capital assets in *Quinn v. State*, the first returns and tax payments were due in April 2023. The Committee will receive a briefing from the Department of Revenue on the implementation and administration of the new tax program. (One work session)

#### Working Families Tax Credit

Beginning February 1, 2023, the Department of Revenue began accepting applications for the Working Families Tax Credit (WFTC) for the first time. The Committee will receive a briefing about the implementation and administration of the new WFTC program. (One work session)

#### **Economic and Revenue Forecast**

The Committee will monitor the changes in the national and state economy with a specific focus on the impact of recent changes to revenue policy. The Committee will receive a briefing on the November economic and revenue forecast as adopted by the Washington State Economic and Revenue Forecast Council. (One work session)

# HEALTH CARE & WELLNESS COMMITTEE WORKPLAN

### **Certificate of Need**

The Health Care and Wellness Committee (Committee) will hold a work session to better understand the Department of Health's certificate of need process and the types of facilities and services that it regulates. (One work session)

#### **Health Care Costs**

As health care costs have risen in Washington and across the country, the Legislature has considered and enacted a number of measures aimed at reducing health care costs while ensuring access to health care services. The Committee will hold a work session to receive updates on some of these measures and consider other possible initiatives. (One work session)

### **Behavioral Health**

The Committee will hold a work session to consider topics affecting access to behavioral health services, including behavioral health workforce development and the expansion of the behavioral health crisis system. The Committee will also consider how the behavioral health system can support other health system efforts such as assisting hospitals with discharging patients who are unable to find behavioral health services in the community. (One work session)

#### **Telemedicine and Health Care Technology**

The Committee will explore topics related to telemedicine and health care technology, including the use of technology to modernize and expand access to medical records and health care services. (One work session)

### **Public Health**

The Committee will hold a work session to learn about current and future public health concerns, such as the status of preventive health services coverage, maternal mortality rates and birth outcomes, the rate of sexually transmitted infections, and possible public health implications of high-potency tetrahydrocannabinol (THC) products. (One work session)

#### Health Care Workforce

The Committee will hold a work session to obtain a better understanding of the extent of health care workforce shortages in Washington and explore methods to address such shortages to preserve access to health care services. (One work session)

#### **Common Interest Communities**

The Housing Committee (Committee) will consider issues, including barriers to homeownership, related to residential common interest communities, such as condominiums, cooperatives, and homeowners' associations. (One work session)

#### Land Banking

The Committee will hold a work session focused on land banking and how the state and local governments can purchase property for future affordable housing development. (One work session)

#### Affordable Housing Incentives

To help address the state's housing crisis, the Legislature has considered and enacted a number of affordable housing incentives, including tax exemptions, density bonuses, expedited project permitting, and fee waivers and reductions. For example, in 2023 the Committee heard House Bill 1350 (relating to expanding the multifamily tax exemption), House Bill 1167 (concerning housing development regulations), and House Bill 1611 (relating to local government permitting). The Committee will hold a work session to consider the effectiveness of such incentives in increasing affordable housing development. (One work session)

#### **Permanent Supportive Housing**

The Committee will explore the creation of a state insurance pool for non-profit organizations offering permanent supportive housing. (One work session)

# **Employer-Sponsored Apprenticeship Programs**

The Labor and Workplace Standards Committee (Committee) will review the current process for employers to sponsor apprenticeship programs approved by the Washington State Apprenticeship and Training Council (WSATC), including developing program standards and addressing competitor objections. The Committee will receive briefings from the WSATC and other relevant stakeholders. Interested members of the Postsecondary Education and Workforce Committee will be invited to the work session. (One work session)

#### **Underground Economy in the Construction Industry**

The Committee will receive a briefing from the Washington State Institute for Public Policy on the findings from its study on the nature and scope of the underground economy in the construction industry. (One work session)

#### **Prevailing Wages on Public Works**

The Washington State Prevailing Wages on Public Works Act, also known as the "Prevailing Wage Law," requires workers to be paid prevailing wages when employed on public works projects. The Committee will evaluate the method by which the Department of Labor and Industries determines prevailing wages and review any applicable emerging case law. (One work session)

#### Workers' Compensation Return-to-Work Policies and Practices

The Committee recently considered legislation to expand the Stay at Work Program (Program), which provides financial incentives to employers for providing temporary, light duty work to injured workers. The Committee will evaluate the Program and other return-to-work policies and practices, including the advantages and disadvantages to employers and injured workers. (One work session)

### **Unemployment Insurance Benefits for Apprentices**

The Legislature directed the Employment Security Department (Department) to convene a work group for the purpose of identifying and addressing legal and procedural barriers faced by eligible claimants participating in apprenticeship programs when those claimants seek timely access to unemployment insurance benefits. The Committee will receive a briefing from the Department on its finding and recommendations. (One work session)

# Growth Management Act Planning From the Local Government Perspective

The Local Government Committee (Committee) will review the Growth Management Act (GMA) and other planning requirements from the local government level. This will include hearing from stakeholders about the process of preparing a comprehensive plan under the GMA, how residential zoning and land use planning are conducted, how the State and National Environmental Policy Acts are complied with, the incorporation of climate change and resiliency planning pursuant to House Bill 1181 (2023), and planning requirements under the Shoreline Management Act. (One work session)

#### **Local Government Legislative Priorities**

The Committee will hear from a panel of local government stakeholders about their priorities and suggestions for legislation during the 2024 session, including suggestions about local government taxation authority and other funding sources, and local government hiring and work force shortage issues. (One work session)

# Local Government Update on Implementation of 2023 Growth Management Act and State Environmental Policy Act Legislation

The Committee will hear from a panel of local governments about the implementation of legislation related to the Growth Management Act and the State Environmental Policy Act passed by the Committee and enacted during the 2023 legislative session, including Engrossed Second Substitute House Bill 1181, Substitute Senate Bill 5374, Senate Bill 5457, and Second Substitute Senate Bill 5412. (One work session)

### State Building Code Council Code Development Review

The Committee will hear a presentation from the State Building Code Council about the process that the Council uses to amend the building and energy codes, including the role that the public and the Legislature play in the code development process, and how future legislation can fit into the process. (One work session)

# POSTSECONDARY EDUCATION & WORKFORCE COMMITTEE WORKPLAN

### Automation and the Future of the Workforce

The Postsecondary Education and Workforce Committee (Committee) will explore how technological innovation is altering and disrupting the workforce and assess how, or whether, the postsecondary education system is adapting. The Committee will receive a briefing from the Workforce Training and Education Coordinating Board detailing what occupations will be most impacted by artificial intelligence (AI), how policy can shape the scope of AI, and how the postsecondary education system can prepare the workforce for advancements in AI. (One work session)

### Vocational Education and Apprenticeships Versus College

The Committee will examine emerging structural and societal trends of educational attainment via trade school versus college, such as shifts in focus from degrees to skills. The Committee will receive a briefing from the Department of Labor and Industries, the Workforce Training and Education Coordinating Board, and other stakeholders. (One work session)

#### **Student Basic Needs**

The Committee will examine access to resources and support services for postsecondary student basic needs such as food, water, shelter, clothing, physical health, mental health, childcare, and similar needs. (One work session)

### High School to Postsecondary Pipeline

A recent report by the Washington Student Achievement Council details the decrease in high school to postsecondary enrollment rates since the COVID-19 pandemic. The Committee will analyze educational attainment outcomes for public high school graduates with a focus on students who graduated during the pandemic and the demographics most impacted. (One work session)

#### **Credential Transparency**

The Committee will evaluate credential transparency data integration across the education and workforce data systems. The Committee will also explore how credential transparency impacts the educational, career, and economic momentum of Washingtonians. (One work session)

### **Mentoring and Wraparound Services**

The Committee will explore holistic, tailored wraparound services that support access to post-high school education such as financial aid assistance, community mentorship, transportation, selecting courses, and others. The Committee will receive a briefing from LaunchNW, an organization that works with community partners to provide wraparound support for students in Spokane. (One work session)

### **Community and Technical College Apprenticeship Programs**

The Committee will learn about community and technical college apprenticeship programs, including attainment and completion rates, barriers to access, and programs offered. (One work session)

# **Community and Technical Colleges Adjunct Wage Equity**

The Committee will explore the discrepancy between adjunct professor wages and tenure-track faculty professor wages, including examining per-course wages for adjunct faculty across various community and technical colleges. The Committee will discuss potential solutions to make wages more equitable for adjunct professors at community and technical colleges. (One work session)

#### **Attainment and Completion Rates**

The Committee will review trends in postsecondary education attainment and completion rates among various demographics including race and gender. The Committee will discuss ways to increase the number of students completing the Free Application for Federal Student Aid (FAFSA) in Washington to encourage more students to pursue postsecondary education. The Committee will also examine barriers to degree completion faced by students across various demographics and discuss solutions to reducing those barriers to help students complete postsecondary education. (One work session)

The Committee will receive an update from the LCB regarding compliance with alcohol delivery laws and regulations, and will consider the LCB's recommendations in the alcohol delivery report required by Substitute Senate Bill 5448 (2023). (One work session)

# TRANSPORTATION COMMITTEE WORKPLAN

# **Climate Commitment Act—Transportation Funding Implementation**

The Transportation Committee (Committee) will be updated on transportation programs, projects, and other agency activities funded with Climate Commitment Act revenue through the 2022 Move Ahead WA transportation package and the 2023-25 Transportation Budget, as well as on related zero-emission vehicle transportation activities. Updates to the Committee will cover existing and newly established programs and projects in the areas of active transportation, alternative fuel vehicles and infrastructure, ferries, rail, ports, and transit. The Committee will receive briefings from a range of state government entities, including the Washington State Department of Transportation, the Electric Vehicle Coordinating Council, the Department of Commerce, and the Department of Ecology. The Committee will also be updated on Low Carbon Fuel Standard (LCFS) and the Healthy Environment for All Act (HEAL Act) implementation. (One work session)

# Washington State Ferries Workforce Development and Diversity, Equity, and Inclusion Efforts

The Committee will monitor the progress within the Washington State Ferries (WSF) at the Washington State Department of Transportation (WSDOT) to address its workforce shortage. The Legislature passed Senate Bill 5550 (SB 5550) in 2023 to implement the WSF workforce plan developed in partnership with the Joint Transportation Committee (JTC). The 2023-25 Transportation Budget also included additional funding for the Career Opportunities Maritime Support Services (COMPASS) program at the WSDOT to support increasing diversity in the maritime industry. The Committee will receive a presentation on the status of filling the staffing gaps which have led to service reductions and unreliable service; diversity, equity, and inclusion (DEI) efforts to transform the WSF workforce; and progress on other recommendations of the JTC workforce plan and the other requirements of SB 5550. (One work session)

# Washington State Patrol Workforce Development and Diversity, Equity, and Inclusion Efforts

The Committee will monitor the progress made by the Washington State Patrol (WSP) in addressing its shortages of both commissioned and non-commissioned staff. Recent legislative actions have included investing in trooper bonuses, establishing lateral hire bonuses and expedited training programs, and directing the Governor's Office of Equity to oversee and support the WSP's efforts to diversify its workforce. The Committee will receive presentations from the WSP and the Office of Equity on the status of hiring and training both commissioned and non-commissioned staff and the incorporation of DEI into the recruiting process and the culture of the organization. (One work session)

# Efforts at the Washington State Department of Transportation and Office of Minority and Women's Business Enterprises to Improve Diversity, Equity, and Inclusion in the Highway Construction Industry

The Committee will monitor the progress of the implementation of additional funding provided in the 2023-25 Transportation Budget for the Preapprenticeship Support Services (PASS) program at the WSDOT and for the Office of Minority and Women's Business Enterprises (OMWBE) to increase diversity in the highway construction and commercial trucking industries. The Committee will receive presentations from the WSDOT and OMWBE on the status of increasing diversity, equity, and inclusion of minorities and women and their businesses in the highway construction and commercial trucking industries. (One work session)
