SB 6073 ADJUSTING ASSESSMENTS LEVIED ON HARDWOOD PROCESSORS

Prime Sponsor: Senator Takko

(HB 2553 Representative Blake)

C 71 L 18 Effective date 7/1/2018.

- Amends the assessment on hardwood processors to be \$0.04 per ton produced.
- Allows the assessment to be adjusted annually beginning July 1, 2019, to reflect the percentage change in the implicit price deflator for personal consumption expenditures.

ESSB 6091 ENSURING THAT WATER IS AVAILABLE TO SUPPORT DEVELOPMENT

Prime Sponsor: Senator Van De Wege

C 1 L 18 Effective date 1/19/2018.

- Establishes that evidence of potable water for a building permit must meet certain requirements based on the Water Resource Inventory Area (WRIA) that the permit is located.
- Establishes that a county or city may rely on or refer to applicable minimum instream flow rules adopted by Department of Ecology (Ecology) for purposes of complying with the Growth Management Act relating to water resources.
- Requires that in certain WRIAs, Ecology must work with the planning units in those WRIAs to update the watershed plan to meet certain additional requirements.
- Requires that Ecology establish Watershed Restoration and Enhancement (WRE) committees and adopt WRE plans in other certain WRIAs.
- Requires that Ecology initiate two pilot projects in specified WRIAs to measure all new groundwater withdrawals.
- Creates a Joint Legislative Task Force to review the treatment of surface water and groundwater appropriations as they relate to instream flows and fish habitat, and to develop and recommend a mitigation sequencing process and a scoring system to address such appropriations.

SB 6125 **EXTENDING THE EXPIRATION DATE OF THE DEPARTMENT OF ECOLOGY'S AUTHORITY TO ENTER INTO VOLUNTARY REGIONAL AGREEMENTS**

Prime Sponsor: Senator Honeyford

C 72 L 18 Effective date 6/7/2018.

• Extends the expiration date from June 30, 2018, to June 30, 2024, for the Department of Ecology's authority to enter into voluntary regional agreements for the purposes of providing new water for out-of-stream use in the Columbia River basin.

ESSB 6127 IMPROVING THE MANAGEMENT OF THE STATE'S HALIBUT FISHERY

Prime Sponsor: Senator Van De Wege

C 190 L 18 Effective date 6/7/2018.

- Authorizes a fee of no more than \$5 for a halibut catch record card when purchased with an annual fishing license, and provides a card at no cost with the purchase of a one-day salt water fishing license or charter stamp.
- Provides revenues from halibut catch record card sales for monitoring and management of recreational halibut fisheries, including expanding recreational fishing opportunities.

ESB 6211 CONCERNING THE FISH AND WILDLIFE FEDERAL LANDS REVOLVING ACCOUNT AND THE NATURAL RESOURCES FEDERAL LANDS REVOLVING ACCOUNT.

Prime Sponsor: Senator Hawkins

C 258 L 18 Effective date 3/23/2018.

• Establishes non-appropriated, interest retaining accounts for the Department of Natural Resources and Department of Fish and Wildlife to receive and expend funds relating to good neighbor agreements with the federal government.

SB 6278 CONCERNING THE USE OF SEED CERTIFICATION FEES

Prime Sponsor: Senator Warnick

C 233 L 18 Effective date 6/7/2018.

• Allows fees collected for certifying seeds to be used for services involving breeder seed, foundation seed, registered seed, and certified seed.

SSB 6317 INCREASING COMMERCIAL FISHING LICENSE FEES FOR NONRESIDENTS

Prime Sponsor: Senator Van De Wege

(HB 2626 Representative Blake)

C 235 L 18 Effective date 6/7/2018*.

- Increases fees for nonresident commercial fishing, dealing, and delivery licenses.
- Reduces resident fees for fish guide licenses and certain wholesale fish buyer's endorsements.
- Expands statutory authorization for the ceremonial and subsistence fishery of the Wanapum Band of Indians to include freshwater food fish.
- SSB 6318 CLARIFYING EXISTING LAW BY CREATING A NEW INTRASTATE FOOD SAFETY AND SECURITY CHAPTER FROM EXISTING INTRASTATE FOOD SAFETY LAWS AND MOVING CERTAIN PROVISIONS IN THE INTRASTATE COMMERCE FOOD, DRUGS, AND COSMETICS ACT TO THE TITLES OF THE AGENCIES THAT ADMINISTER THE PROVISIONS

Prime Sponsor: Senator Takko

C 236 L 18 Effective date 6/7/2018.

- Moves existing statutes to create the Food Safety and Security Act in Title 15 RCW.
- Maintains Washington's Department of Agriculture authority in the Food Safety and Security Act, including the authority to: establish standards for food and set standards for pull date labeling and storage conditions for perishable packaged foods; and license food businesses, investigate violations or possible violations, and enforce penalties.
- Moves provisions relating to fish and shellfish labeling to Title 77 RCW.

SB 6319 IMPLEMENTING THE FEDERAL PRODUCE SAFETY RULE

Prime Sponsor: Senator Honeyford

(HB 2681 Representative Springer)

C 106 L 18 Effective date 6/7/2018.

- Provides that the Washington State Department of Agriculture (WSDA) may take actions necessary to cooperate in the implementation of the Produce Safety Rule.
- Authorizes WSDA to take certain actions in order to verify farm compliance with the Produce Safety Rule if federal funding is provided.
- Allows WSDA to establish a voluntary program for farms exempt or partially exempt from the Produce Safety Rule to verify that those farms comply with the rule.

SB 6369 CONCERNING CERTIFICATES OF VETERINARY INSPECTION FOR ANIMALS BROUGHT INTO THE STATE

Prime Sponsor: Senator Warnick

(HB 2654 Representative Blake)

C 281 L 18 Effective date 6/7/2018.

• Removes an exemption from the requirement to obtain a certificate of veterinary inspection for animals that will be delivered to a feed lot for slaughter.

SHB 2276 CONCERNING NOTIFICATION OF WILDLIFE TRANSFER, RELOCATION, OR INTRODUCTION INTO A NEW LOCATION

Prime Sponsor: Representative Eslick

C 212 L 18 Effective date 6/7/2018.

• Requires that the Department of Fish and Wildlife provide notice and hold a public hearing prior to the relocation or introduction of certain wildlife into a different location in the state.

ESHB 2285 **ESTABLISHING A REPORTING PROCESS FOR THE DEPARTMENT OF NATURAL RESOURCES REGARDING**CERTAIN MARBLED MURRELET HABITAT INFORMATION

Prime Sponsor: Representative Chapman

(SB 6020 Senator Van De Wege)

C 255 L 18 Effective date 6/7/2018.

• Requires that the Department of Natural Resources annually provide certain information and recommendations relating to the proposed long term marbled murrelet conservation strategy for state lands and state forestlands.

HB 2307 REQUIRING CONFIDENTIALITY IN THE RELEASE OF SENSITIVE FISH AND WILDLIFE DATA

Prime Sponsor: Representative Van Werven

C 214 L 18 Effective date 6/7/2018*.

Requires that release of sensitive fish and wildlife data be subject to a confidentiality agreement.

SHB 2342 **ESTABLISHING A DONATION PROGRAM FOR RESIDENT DISABLED VETERANS TO RECEIVE HUNTING AND FISHING LICENSES**

Prime Sponsor: Representative Lovick

(SB 6181 Senator Bailey)

C 90 L 18 Effective date 6/7/2018.

• Authorizes the Washington Department of Fish and Wildlife to establish a program that accepts public donations to be applied towards qualified disabled veteran hunting and fishing license purchases.

SHB 2561 CONCERNING TEMPORARY DUTIES FOR THE WILDLAND FIRE ADVISORY COMMITTEE

Prime Sponsor: Representative Dent

C 227 L 18 Effective date 6/7/2018.

• Directs the Wildland Fire Advisory Committee to review and make recommendations on specified wildfire-related issues.

SHB 2639 **EXEMPTING CERTAIN MOBILE FOOD UNITS FROM STATE AND LOCAL REGULATIONS PERTAINING TO COMMISSARIES OR SERVICING AREAS**

Prime Sponsor: Representative Buys

C 167 L 18 Effective date 6/7/2018.

• Allows a regulatory authority to exempt mobile food units from requirements to store, prepare, and package food in a separate food establishment under certain circumstances.

HB 2649 ENHANCING THE FISH, SHELLFISH, AND WILDLIFE-RELATED RECREATIONAL OPPORTUNITIES FOR A PERSON WITH A DISABILITY

Prime Sponsor: Representative Barkis

C 168 L 18 Effective date 6/7/2018.

- Directs the Fish and Wildlife Commission (Commission) to enhance the fish, shellfish, and wildlife-related recreational opportunities for a person with a disability.
- Requires the Commission to adopt rules defining who is a person with a disability and establish eligibility requirements for a disability designation.
- Requires the director of the Department of Fish and Wildlife to grant a disability designation to persons that meet eligibility criteria.
- Provides that a person granted a disability designation is not guilty of violating the unlawful possession or use of a loaded rifle or shotgun in a vehicle provisions in the Fish and Wildlife Enforcement Code.

ESHB 2658 CONCERNING THE USE OF PERFLUORINATED CHEMICALS IN FOOD PACKAGING

Prime Sponsor: Representative McBride

(SB 6396 Senator Wellman)

C 138 L 18 Effective date 6/7/2018.

- Requires the Department of Ecology (Ecology) to conduct an alternatives assessment of safer alternatives to perfluorinated (PFA) chemicals for specific food packaging applications as part of the Ecology and the Department of Health Chemical Action Plan.
- Prohibits the use of PFA chemicals for specific food packaging applications if the alternatives assessment identifies multiple safer alternatives that meet certain requirements.
- Requires identified safer alternatives be supported by an external peer review.
- Requires safer alternatives that are chemical to be approved for food contact by the U.S. Food and Drug Administration.
- Provides compliance guidelines certifications for manufacturers.

HB 2682 **EXEMPTING HOP GROWER LOT INFORMATION USED IN THE STATE DEPARTMENT OF AGRICULTURE EXPORT DOCUMENT FROM PUBLIC DISCLOSURE**

Prime Sponsor: Representative Buys

C 170 L 18 Effective date 6/7/2018.

• Exempts from public disclosure hop grower lot numbers and associated laboratory results used by the Washington Department of Agriculture to issue export documents.

HB 2733 ESTABLISHING A PRESCRIBED BURN CERTIFICATION PROGRAM AT THE DEPARTMENT OF NATURAL RESOURCES

Prime Sponsor: Representative Orcutt

C 172 L 18 Effective date 6/7/2018.

• Establishes a prescribed burn manager certification program within the Department of Natural Resources.

EHB 2957 REDUCING ESCAPE OF NONNATIVE FINFISH FROM MARINE FINFISH AQUACULTURE FACILITIES

Prime Sponsor: Representative Lytton

C 179 L 18 Partial Veto Effective date 6/7/2018.

- Prohibits the Department of Natural Resources from renewing, extending, or entering into an existing, aquatics land lease or use authorization that allows nonnative marine finfish aquaculture as an authorized use.
- Prohibits specified state regulatory agencies from authorizing or permitting activities associated with the use of marine net pens for nonnative marine finfish aquaculture after the expiration date for the existing aquatic lands lease.
- Creates a reoccurring facility inspection process for operations involving marine finfish aquaculture.
- Directs specified state agencies to update existing guidance and resources on planning for and permitting commercial marine net pen aquaculture.
- Specifies that separation from employment as a result of the bill is a qualifying event for purposes of the Training Benefits Program.

Partial Veto: Vetoed section:

SSB 5064 CONCERNING FREEDOM OF EXPRESSION RIGHTS OF STUDENTS AT PUBLIC SCHOOLS AND INSTITUTIONS OF HIGHER EDUCATION

Prime Sponsor: Senator Fain

C 125 L 18 Effective date 6/7/2018.

- Expands free speech protections for student media in public high schools and institutions of higher education.
- Excludes any media produced by students at public institutions of higher education from mandatory prior review.
- Prohibits the discipline or termination of student media advisors for failing to suppress school sponsored media.
- Protects school officials from civil or criminal liability resulting from school sponsored media.

SSB 6133 EXPANDING STATEWIDE CAREER AND TECHNICAL EDUCATION COURSE EQUIVALENCY OPTIONS

Prime Sponsor: Senator Zeiger

(HB 2494 Representative Santos)

C 191 L 18 Effective date 6/7/2018.

• Changes the content areas in which career and technical education courses may be approved as equivalent to academic courses for the purposes of high school graduation.

SB 6134 MODIFYING DEFINITIONS FOR ALTERNATIVE LEARNING EXPERIENCE COURSES

Prime Sponsor: Senator Wellman

(HB 2492 Representative Santos)

C 56 L 18 Effective date 6/7/2018.

- Modifies the definition of remote course to an alternative-learning experience (ALE) course that is not online and when the written student learning plan does not include a requirement for in-person instructional contract time.
- Changes the definition of site-based course to an ALE course that has a written student learning plan that includes a requirement for in-person instructional contact time.

SB 6136 REMOVING CONCURRENT ENROLLMENT REQUIREMENT OF ALGEBRA II FOR AP COMPUTER SCIENCE COURSES TO BE COUNTED AS EQUIVALENT TO HIGH SCHOOL MATHEMATICS

Prime Sponsor: Senator Rolfes

(HB 2491 Representative Santos)

C 73 L 18 Effective date 6/7/2018.

• Removes the requirement for a student to be concurrently enrolled in or have successfully completed algebra II for AP computer science to be counted as a career and technical equivalent to high school mathematics.

E2SSB 6162 **DEFINING DYSLEXIA AS A SPECIFIC LEARNING DISABILITY AND REQUIRING EARLY SCREENING FOR DYSLEXIA**

Prime Sponsor: Senator Zeiger

(HB 2796 Representative Pollet)

C 75 L 18 Effective date 6/7/2018.

- Requires each school district to conduct student screenings for indications of dyslexia in grades kindergarten through second grade, beginning in 2021-22.
- Authorizes Learning Assistance Program allocations to be used for staff trainings to implement the required dyslexia screenings and to provide the required interventions, which must be multi-tiered systems of support that meet certain requirements.

ESSB 6257 DEVELOPING A FUNDING MODEL FOR EARLY INTERVENTION SERVICES FOR ELIGIBLE CHILDREN.

Prime Sponsor: Senator Billig

(HB 2650 Representative Stonier)

C 261 L 18 Effective date 6/7/2018.

- Tasks certain agencies with developing a funding model with which to determine the amount of allocations in the budget after July 1, 2019, for early intervention services for children with disabilities from birth through two years of age.
- Requires the Department of Children, Youth, and Families to submit a report by September 1, 2018, to the Office of Financial Management and the Legislature.

E2SSB 6362 MODIFYING BASIC EDUCATION FUNDING PROVISIONS

Prime Sponsor: Senator Wellman

(HB 2721 Representative Sullivan)

C 266 L 18 Partial Veto Effective date 6/7/2018*.

- Implements the full increased salaries in the 2018-19 school year required by the Court.
- Adjusts salary regionalization and salary rebasing criteria, and adds an education and experience factor for salaries.
- Specifies an inflation measure for salaries, levies and local effort assistance.
- Increases the special education base allocation and excess cost multiplier, and directs changes to the special education safety net rules.
- Creates a transportation alternative funding grant program.
- Delays the requirement that districts meet the K-3 class size ratios until the 2019-20 school year; and the implementation of the state allocation for professional learning days by one year.
- Appropriates \$12 million for hold-harmless payments to districts for the 2018-19 and 2019-20 school years meeting specified criteria.
- Establishes a work group to make recommendations for defining duties performed in a school day.
- Authorizes curricula to engage students in seasonal or non-seasonal outdoor-based activities.

Partial Veto: Vetoed sections:

- Delaying the phase-in of three professional learning days to begin in the 2019-20 school year instead of the 2018-19 school year.
- Moving up from the 2019-20 school year to the 2018-19 school year the requirement for OSPI to adopt rules to require school districts to provide separate accounting of state and local revenues to expenditures from the 2019-20 school year to the 2018-19 school year.

SSB 6388 CONCERNING PARAEDUCATORS

Prime Sponsor: Senator Mullet

(HB 2698 Representative Bergquist)

C 153 L 18 Effective date 6/7/2018.

- Creates a timeline for paraeducators to meet certain minimum employment standards.
- Specifies that experienced paraeducators hired before or during the 2017-18 school year must meet employment standards by the 2019-20 school year.
- Specifies that new paraeducators must meet employment standards by the 2018-19 school year.
- Requires school districts to provide fundamental paraeducator training courses to paraeducators in school years for which state funding is appropriated.

SB 6404 CONCERNING BACKGROUND CHECKS FOR PERSONS PROVIDING CHILD CARE SERVICES

Prime Sponsor: Senator Wellman

(HB 2784 Representative Goodman)

C 59 L 18 Effective date 7/1/2018.

- Requires child care licensees and their employees to submit a new background application with accompanying fees to the Department of Children, Youth, and Families when renewing their background clearance cards or certificates.
- Provides that background check payment requirements do not apply to in-home/relative providers who receive child care subsidies.

SSB 6419 CONCERNING ACCESS TO THE WASHINGTON EARLY CHILDHOOD EDUCATION AND ASSISTANCE PROGRAM

Prime Sponsor: Senator Rolfes

C 155 L 18 Effective date 7/1/2018.

- Directs the Department of Children, Youth, and Families to adopt rules that allow children whose families do not meet income eligibility requirements but are homeless or impacted by certain risk factors to be included in the Early Childhood Education and Assistance Program (ECEAP) on a space available basis.
- Provides that these children are not part of the state-funded ECEAP entitlement, which will become an entitlement in the 2022-23 school year.
- Specifies certain priorities for children enrolled in ECEAP.

SSB 6474 CREATING A PILOT PROJECT FOR TRIBAL COMPACT SCHOOLS

Prime Sponsor: Senator McCoy

C 290 L 18 Effective date 6/7/2018.

• Creates a pilot project for tribal compact schools to grant schools flexibility with respect to school attendance and calendar requirements; accommodating cultural and agricultural events; and replacing graduating testing requirements with culturally relevant and community-based standards.

2SHB 1377 IMPROVING STUDENTS' MENTAL HEALTH BY ENHANCING NONACADEMIC PROFESSIONAL SERVICES

Prime Sponsor: Representative Ortiz-Self
C 200 L 18 Effective date 6/7/2018.

- Defines and describes the roles of school counselors, psychologists, and social workers.
- Requires school districts with 2000 or more students to provide a minimum of six hours per year, within existing resources, for school professionals to collaborate with mental health service providers beginning in the 2019-20 school year.
- Establishes a grant program to assist school districts with implementing the mental health professional collaboration time.

SHB 1539 REGARDING A CURRICULUM FOR THE PREVENTION OF SEXUAL ABUSE OF STUDENTS

Prime Sponsor: Representative McCabe

C 64 L 18 Effective date 6/7/2018**.

- Requires the Office of the Superintendent of Public Instruction (OSPI) to review and evaluate any existing curricula related to the prevention of sexual abuse of students by June 30, 2019.
- Tasks OSPI with seeking advice and comments from certain entities regarding any curriculum included within a voluntary coordinated program for the prevention of sexual abuse, child abuse, and neglect.
- Directs OSPI to make curriculum available on its website.

E2SHB 1600 INCREASING THE CAREER AND COLLEGE READINESS OF PUBLIC SCHOOL STUDENTS

Prime Sponsor: Representative Santos

C 206 L 18 Effective date 6/7/2018.

- Creates the Work-Integrated Learning Initiative with the goal of promoting these types of learning experiences for students.
- Authorizes the Office of the Superintendent of Public Instruction (OSPI) to contract with a statewide non-profit organization with expertise in work-integrated learning to establish a matching grant program to fund projects implemented by local schools.
- Requires OSPI, in consultation with the Employment Security Department and the Workforce Training and Education Coordinating Board, to convene a Work-Integrated Learning Advisory Committee to provide advice to the Legislature and the education and workforce sectors on creating opportunities for students.

2SHB 1896 EXPANDING CIVICS EDUCATION IN PUBLIC SCHOOL

Prime Sponsor: Representative Dolan

(SB 5668 Senator Zeiger)

C 127 L 18 Effective date 6/7/2018.

- Requires each school district with a high school to provide a mandatory half-credit stand-alone civics course with specific content requirements by the 2020-21 school year.
- Allows school districts to embed civics content and instruction in dual credit courses.
- Establishes an expanded civics education teacher training program within the Office of the Superintendent of Public Instruction (OSPI), subject to the availability of funds, to provide civics-specific teacher training, professional learning opportunities, and developed teacher training materials.
- Instructs OSPI to select two school districts to serve as demonstration sites for enhanced civics education.
- Transfers administration and coordination of the Washington History Day Program from the Washington State Historical Society to OSPI, effective July 1, 2018.

ESHB 2610 CREATING THE HUNGER-FREE STUDENTS' BILL OF RIGHTS ACT

Prime Sponsor: Representative Peterson
C 271 L 18 Effective date 6/7/2018.

- Requires schools to take certain actions regarding free and reduced-price meal applications and direct certification of students for these meals.
- Directs schools to take certain actions when a student has not paid for five or more previous meals and prohibits certain actions when there are unpaid meals.
- Tasks the Office of the Superintendent of Public Instruction (OSPI) with collecting, analyzing, and promoting best practices in local meal charge policies.
- Directs OSPI to develop and implement a plan to increase the number of schools participating in the community eligibility provision, which allows schools with high numbers of low income children to serve fre breakfast and lunch to all students without collecting meal applications.

ESHB 2684 DEFINING THE PROCESS FOR BEST INTEREST DETERMINATIONS OF STUDENTS IN OUT-OF-HOME CARE

Prime Sponsor: Representative Caldier

C 139 L 18 Effective date 9/1/2018.

- Directs school districts to collaborate with the Department of Children, Youth, and Families to develop protocols regarding the status and progress of students in out-of-home care.
- Provides guidance and requirements for best interest determinations for students in out-of-home care before changing the school placement of a student.
- Requires school districts to designate a foster care liaison to facilitate compliance with state and federal laws.

SHB 2685 PROMOTING PREAPPRENTICESHIP OPPORTUNITIES FOR HIGH SCHOOL STUDENTS

Prime Sponsor: Representative Ortiz-Self

C 228 L 18 Effective date 6/7/2018.

- Requires the Office of the Superintendent of Public Instruction (OSPI), in consultation with the State Board for Community and Technical colleges and the Washington State Apprenticeship and Training Council, to examine opportunities for promoting pre-apprenticeship and youth apprenticeship programs for high school students.
- Instructs OSPI to solicit input from stakeholders and submit a report to the Governor and the Legislature with recommendations for: (1) improving vocational course alignment; (2) identifying and removing barriers to apprenticeship opportunities; and (3) increasing awareness of apprenticeship programs.

SHB 2686 CONCERNING HIGH SCHOOL AND BEYOND PLANS

Prime Sponsor: Representative Ortiz-Self

C 229 L 18 Effective date 6/7/2018.

- Modifies the requirements of High School and Beyond Plans by directing districts to provide them in the parent's native language in certain circumstances and adding to the minimum elements.
- Tasks the Office of the Superintendent of Public Instruction with identifing best practices for those plans.

HB 2816 TRANSFERRING THE WORKING CONNECTIONS AND SEASONAL CHILD CARE PROGRAMS TO THE DEPARTMENT OF CHILDREN, YOUTH, AND FAMILIES

Prime Sponsor: Representative Senn

(SB 6441 Senator Billig)

C 52 L 18 Effective date 7/1/2019.

• Transfers all powers, duties, and functions of the Department of Social and Health Services pertaining to Working Connections Child Care and Seasonal Child Care to the Department of Children, Youth, and Families on July 1, 2019.

C 286 L 18 Effective date 6/7/2018.

- Prohibits the sale, manufacture, and distribution of firefighting foam that has perfluoroalkyl and polyfluoroalkyl chemicals (PFAs) intentionally added.

• Makes it unprofessional conduct for a licensed health care provider to perform conversion therapy on a patient under the age of 18.

SSB 6452 **EXPANDING THE ACTIVITIES OF THE CHILDREN'S MENTAL HEALTH SERVICES CONSULTATION PROGRAM**

C 288 L 18 Effective date 6/7/2018.

- Removes the pilot designation for currently existing Partnership Access Line (PAL) consultation services.
- Establishes a two-year PAL pilot program for Moms and Kids, beginning January 1, 2019, to expand the activities of PAL to include support for health care professionals who provide care to pregnant women and new mothers, and assist parents or guardians with making mental health service connections.
- Requires the Health Care Authority (HCA) to collaborate with the University of Washington and Seattle Children's Hospital to report pilot outcomes annually.
- Requires that HCA must convene a group of specified stakeholders to write a report that recommends an alternative funding model for PAL and a strategy to ensure that expanded PAL services do not duplicate existing Managed Care Organization requirements, and submit the report to the Legislature and the Children's Mental Health Workgroup by December 1, 2018.

2SSB 6453 CONCERNING LEGAL SUPPORT FOR KINSHIP CAREGIVERS

(HB 2663 Representative Pettigrew)

C 80 L 18 Effective date 6/7/2018.

- Authorizes the Department of Social and Health Services (DSHS) to purchase legal representation for kinship caregivers of children who are dependent or at risk of being dependent for the purposes of non-parental custody actions and establishing other relevant civil legal relationships within existing appropriations.
- Encourages DSHS to work with the Office of Public Defense and the Office of Civil Legal Aid to develop cost-effective legal representation for kinship caregivers if DSHS exercises its authority to purchase legal representation.

ESSB 6491 INCREASING THE AVAILABILITY OF ASSISTED OUTPATIENT BEHAVIORAL HEALTH TREATMENT

Prime Sponsor: Senator O'Ban

C 291 L 18 Effective date 4/1/2018*.

- Expands assisted outpatient mental health treatment after April 1, 2018, to include substance use disorder treatment and renames it assisted outpatient behavioral health treatment (AOBHT).
- Reduces eligibility criteria for AOBHT and extends and simplifies the filing processes.
- Allows a family member, guardian, or conservator of a person who files a court petition for review of a decision (1) to not detain the person for involuntary treatment; and (2) to request that the court require an AOBHT petition be filed.

ESSB 6550 CONCERNING DIVERSION OF JUVENILE OFFENSES

Prime Sponsor: Senator Darneille

C 82 L 18 Effective date 6/7/2018*.

- Allows prosecutorial discretion to file or divert any case that is not a sex offense or violent offense other than assault 2 or robbery 2, subject to limited exceptions.
- Expands options for the formation of diversion agreements and diversion units.
- Encourages engagement with community programs to expand options to divert youth from formal processing in juvenile court.
- Provides for destruction of a juvenile's criminal records which consist of successfully completed diversions and counsel and release agreements when the juvenile turns 18.

SSB 6560 ENSURING THAT NO YOUTH IS DISCHARGED FROM A PUBLIC SYSTEM OF CARE INTO HOMELESSNESS

Prime Sponsor: Senator Darneille

C 157 L 18 Effective date 6/7/2018*.

- Requires the Department of Children, Youth, and Families (DCYF) and the Office of Homeless Youth Prevention and Protection Programs to jointly develop a plan to ensure that by December 31, 2020, no unaccompanied youth is discharged from a publicly funded system of care into homelessness.
- Requires DCYF to submit this plan to the Legislature and Governor by December 31, 2019.
- Requires the Department of Licensing to issue an identicard at the cost of production to individuals scheduled for release from a juvenile rehabilitation institution or facility and to individuals who were released from those facilities within 30 days before the date of application.

E3SHB 1482 ESTABLISHING THE LEGISLATIVE-EXECUTIVE WORKFIRST POVERTY REDUCTION OVERSIGHT TASK FORCE

(SB 5440 Senator Zeiger)

C 126 L 18 Effective date 6/7/2018.

- Replaces the Legislative-Executive WorkFirst Oversight Task Force with the Legislative-Executive WorkFirst Poverty Reduction Oversight Task Force.
- Creates the Intergenerational Poverty Advisory Committee to advise the Task Force.

E2SHB 1570 CONCERNING ACCESS TO HOMELESS HOUSING AND ASSISTANCE

Prime Sponsor: Representative Macri

C 85 L 18 Effective date 6/7/2018.

- Increases the temporary \$40 local homeless housing and assistance surcharge to \$62, makes the surcharge permanent, and reserves \$10 of the surcharge specifically for use by counties for local homeless housing and assistance purposes.
- Allows counties to pay off general obligation bonds issued by the county for homeless housing and assistance.
- Modifies the state and local homeless housing plans to be five-year plans instead of ten-year plans.
- Creates new and updated reporting requirements for certain homeless assistance programs.

HB 1630 ALLOWING MINORS TO CONSENT TO SHARE THEIR PERSONALLY IDENTIFYING INFORMATION IN THE WASHINGTON HOMELESS CLIENT MANAGEMENT INFORMATION SYSTEM

(SB 5625 Senator Zeiger)

C 15 L 18 Effective date 6/7/2018.

• Allows unaccompanied youth aged 13 and older to give consent for the collection of personally identifying information for the Washington Homeless Client Management Information System.

HB 1790 CONCERNING DEPENDENCY PETITIONS WHERE THE DEPARTMENT OF SOCIAL AND HEALTH SERVICES IS THE PETITIONER

Prime Sponsor: Representative Lovick

C 17 L 18 Effective date 6/7/2018.

• Clarifies that a probation officer is not required to review a dependency petition when the Department of Social and Health Services files the petition.

E2SHB 1831 REVISING RESOURCE LIMITATIONS FOR PUBLIC ASSISTANCE

Prime Sponsor: Representative Pettigrew

C 40 L 18 Effective date 2/1/2019.

• Increases exemptions used in determining eligibility for public assistance, to include up to \$10,000 in equity value for one motor vehicle and up to \$6,000 in value for all other resources.

E2SHB 1889 CREATING AN OFFICE OF THE CORRECTIONS OMBUDS

Prime Sponsor: Representative Pettigrew

C 270 L 18 Effective date 6/7/2018.

- Establishes the Office of Corrections Ombuds within the Governor's Office, subject to appropriations, to report directly to the Governor and independent from the secretary of the Department of Corrections.
- Requires the Governor to appoint an Ombuds for a three-year term with input from the Legislature, Statewide Family Council, and other stakeholders.
- Establishes duties, powers, access requirements, and confidentiality rules for the Ombuds.
- Establishes a sunset date of July 1, 2028.

HB 2261 CONCERNING HOUSING AUTHORITIES

C 42 L 18 Effective date 6/7/2018.

• Allows a state public body to provide monetary, in-kind, or other support to the board of commissioners of a housing authority to carry out the board's duties or powers, but not for the purpose of compensating the commissioners for their service.

3SHB 2382 PROMOTING THE USE OF SURPLUS PUBLIC PROPERTY FOR PUBLIC BENEFIT

C 217 L 18 Effective date 6/7/2018.

- Requires the Department of Commerce to work with designated state agencies to identify, catalog, and recommend the best use for under-utilized, state-owned surplus land and property.
- Allows any state or local agency to dispose of property to any public, private, or nongovernmental body for affordable housing development on any mutually agreed on terms and conditions, except where the law requires the sale at fair market value, with priority given to state agencies.
- Requires that state agencies, except for the Department of Transportation, provide written notice to other relevant governmental bodies at least 60 days prior to the disposal of surplus state property to a private or nongovernmental party and prioritize the disposal for continued public benefit.

SHB 2448 INCREASING THE AVAILABILITY OF HOUSING FOR DEVELOPMENTALLY DISABLED PERSONS

C 223 L 18 Effective date 6/7/2018.

- Exempts certain transfers of residential property by the legal representative of a person with developmental disabilities from the real estate excise tax.
- Authorizes additional eligible uses of Housing Trust Fund monies.

SHB 2667 CONCERNING ELIGIBILITY FOR THE ESSENTIAL NEEDS AND HOUSING SUPPORT AND THE AGED, BLIND, OR DISABLED ASSISTANCE PROGRAMS

(SB 6502 Senator Dhingra)

C 48 L 18 Effective date 6/7/2018*.

- Expands eligibility for an Essential Needs and Housing Support Program (HEN) referral to individuals who receive Aged, Blind, or Disabled (ABD) assistance.
- Allows individuals to receive HEN services and ABD assistance concurrently while awaiting federal supplemental security income benefits.
- Removes the prohibition against HEN assistance for those living with alcohol dependency or substance use disorders.
- Requires the Department of Social and Health Services to share data of HEN-eligible individuals with the Department of Commerce (Commerce).
- Requires Commerce to share basic contact information about HEN-eligible individuals with essential needs and housing support entities.

ESHB 2700 CONCERNING THE HANDLING OF CHILD FORENSIC INTERVIEW AND CHILD INTERVIEW DIGITAL RECORDINGS

(SB 6387 Senator Cleveland)

C 171 L 18 Effective date 3/22/2018*.

- Requires audio and video recordings of child forensic interviews disclosed in a criminal or civil proceeding to be subject to a protective order unless the court finds good cause that the interview should not be subject to such an order.
- Exempts audio and video recordings of child forensic interviews depicting allegations for child abuse, child neglect, or exposure to violence from the Public Records Act except by court order upon a showing of good cause and advance notice to the child's parent, guardian, or legal custodian, or to the child if the child is the age of majority or an emancipated minor.
- Requires every county child sexual abuse investigation protocol to include the same protocols as listed under a court protective order for audio and video recordings of child forensic interviews.

- Directs the Health Care Authority (HCA) to provide staff support for the Workgroup, and to convene at least two, but not more than four meetings each year.
- Adds a pediatrician located east of the crest of the Cascade mountains and a child psychiatrist to the Workgroup membership.

HB 2785 PROVIDING THE LIST OF FOSTER PARENT RIGHTS AND RESPONSIBILITIES TO PROSPECTIVE AND CURRENT FOSTER PARENTS

SSB 5996 ENCOURAGING THE DISCLOSURE AND DISCUSSION OF SEXUAL HARASSMENT AND SEXUAL ASSAULT IN THE WORKPLACE

C 117 L 18 Effective date 6/7/2018.

- Prohibits an employer from requiring an employee, as a condition of employment, to sign a nondisclosure agreement that prevents the employee from disclosing sexual harassment or sexual assault.
- Provides that any nondisclosure agreement that has the purpose or effect of preventing an employee from disclosing or discussing sexual harassment or sexual assault is void and unenforceable.
- Provides that it is an unfair practice under the Washington Law Against Discrimination for an employer to retaliate against an employee for disclosing or discussing sexual harassment or sexual assault.

SSB 6126 REQUIRING COMPLETION OF AN APPRENTICESHIP PROGRAM TO RECEIVE A JOURNEY LEVEL ELECTRICIAN CERTIFICATE OF COMPETENCY

• Requires completion of an apprenticeship program to receive a journey level electrician certificate of competency.

ESSB 6137 CLARIFYING THE RELATIONSHIP BETWEEN MANUFACTURERS AND NEW MOTOR VEHICLE DEALERS BY PROVIDING TOOLS TO RESOLVE DISPARITIES INCLUDING EXPANDING COMPENSATION FOR RECALLED VEHICLES

(EHB 2439 Representative Kirby)

C 296 L 18 Effective date 6/7/2018.

- Requires a manufacturer to compensate its new motor vehicle dealers for labor and parts required to perform recall repairs and to pay compensation while parts are not reasonably available at a rate of at least 1.75 percent of the average trade-in value per month, and prorated for a partial month.
- Modifies prohibitions on adverse action to specify that the designated area contains only areas inside the state of Washington unless specifically approved by the new motor vehicle dealer.
- Requires a manufacturer to give notice and act in good faith when modifying a franchise agreement.
- Permits a new motor vehicle dealers association standing to file a petition in an adjudicative proceeding, or as a civil cause of action.

- Provides that city firefighter, city police, and county sheriff civil service applicants may be lawful permanent residents as an alternative to United States citizens.

- Modifies the background investigation for a fully commissioned peace officer or reserve officer to include proof of lawful permanent residence or United States citizenship.

SB 6197 REGARDING AN EMPLOYER'S PAYMENT OF INDEBTEDNESS UPON THE DEATH OF AN EMPLOYEE

C 57 L 18 Effective date 6/7/2018.

- Authorizes municipal corporations to pay any monies owing to a decedent employee's survivors.

SSB 6214 ALLOWING INDUSTRIAL INSURANCE COVERAGE FOR POSTTRAUMATIC STRESS DISORDERS AFFECTING LAW ENFORCEMENT OFFICERS AND FIREFIGHTERS

C 264 L 18 Effective date 6/7/2018.

- Exempts certain firefighters, emergency medical technicians (EMTs), and law enforcement officers from the Department of Labor and Industries rule that claims based on mental conditions or mental disabilities caused by stress do not fall within the definition of occupational disease.
- Establishes a presumption that post-traumatic stress disorder (PTSD) is an occupational disease for these firefighters, EMTs, and law enforcement officers.

(HB 2736 Representative Sells)

C 252 L 18 Effective date 6/7/2018.

• Provides that the statute of limitations for an unfair labor practice complaint filed in a superior court is six months.

SB 6240 REGARDING MINIATURE HOBBY BOILERS

Prime Sponsor: Senator Sheldon

C 259 L 18 Effective date 6/7/2018.

• Exempts miniature hobby boilers from inspection and other requirements if the miniature hobby boiler is already certified or receives certification before being placed into service.

2SSB 6245 CONCERNING SPOKEN LANGUAGE INTERPRETER SERVICES

Prime Sponsor: Senator Saldaña

C 253 L 18 Effective date 6/7/2018*.

- Requires the Department of Social and Health Services (DSHS), the Health Care Authority (HCA), the Department of Children, Youth, and Families (DCYF), and the Department of Labor and Industries (L&I) to purchase interpreter services directly from language access providers or through contracts with scheduling and coordinating delivery organizations.
- Requires the Department of Enterprise Services (DES) to develop a model for state agencies to use to purchase interpreter services from language access providers or through scheduling and coordinating delivery organizations.
- Places limitations on persons to which DSHS may offer spoken language interpreter testing.
- Authorizes language access providers for DSHS, HCA, DCYF, L&I, and through DES contract to form three separate statewide collective bargaining units for the purposes of collective bargaining with the state.

• Eliminates the exemption from adding a bittering agent for wholesale containers of 55 gallons or more of engine coolant or antifreeze.

HB 1133 LIMITING THE USES OF THE FIRE PROTECTION CONTRACTOR LICENSE FUND

Prime Sponsor: Representative Griffey

C 37 L 18 Effective date 6/7/2018.

• Removes the authority of the state director of Fire Protection to use the Fire Protection Contractor License Fund to pay for costs associated with hospital fire protection inspections.

EHB 1237 MODIFYING COLLECTIVE BARGAINING LAW TO AUTHORIZE PROVIDING ADDITIONAL COMPENSATION TO ACADEMIC EMPLOYEES AT COMMUNITY AND TECHNICAL COLLEGES

C 267 L 18 Partial Veto Effective date 6/7/2018.

• Authorizes boards of trustees of community and technical colleges to provide additional compensation to academic employees that exceeds the amount or percentage established by the Legislature.

Partial Veto: Vetoed section:

• Stating the Legislature's intent to fund academic employee salary and benefit increases with 66 percent state general fund.

2SHB 1298 PROHIBITING EMPLOYERS FROM ASKING ABOUT ARRESTS OR CONVICTIONS BEFORE AN APPLICANT IS DETERMINED OTHERWISE QUALIFIED FOR A POSITION

- Enacts the Washington Fair Chance Act.

- Authorizes the attorney general to enforce the Washington Fair Chance Act and provides penalties.

C 163 L 18 Effective date 6/7/2018.

• Eliminates the Social Security retirement offset for injured workers who either were receiving, or had applied to receive, Social Security benefits before being injured.

2SHB 1506 ADDRESSING WORKPLACE PRACTICES TO ACHIEVE GENDER PAY EQUITY

Prime Sponsor: Representative Senn

C 116 L 18 Effective date 6/7/2018.

- Modifies the Equal Pay Act to prohibit discrimination in compensation, which includes discretionary and nondiscretionary wages and benefits; describes when employees are similarly employed; and provides a defense where a pay differential is based in good faith on bona fide job-related factors.
- Prohibits discrimination related to career advancement opportunities and certain workplace practices related to nondisclosure of wages.

ESHB 1952 CONCERNING ENFORCEMENT OF THE ELECTRICAL LAWS

C 240 L 18 Effective date 6/7/2018.

• Permits cities that conduct electrical inspections to enforce electrical licensing and certification requirements.

• Requires that the Washington Industrial Safety and Health Act's (WISHA) maximum civil penalties be raised if required for WISHA to qualify as a state plan under the Occupational Safety and Health Act, administered by the Occupational Safety and Health Administration.

SHB 2367 ESTABLISHING A CHILD CARE COLLABORATIVE TASK FORCE

C 91 L 18 Effective date 6/7/2018.

- Directs the Department of Commerce to convene and facilitate a Child Care Collaborative Task Force (Task Force) to examine the effects of child care affordability and accessibility on the workforce and on businesses.
- Requires the Task Force to report its findings and recommendations by November 1, 2019.
- HB 2468 ALLOWING FIRMS IN THE CANADIAN PROVINCE OF BRITISH COLUMBIA TO PERFORM ATTEST OR COMPILATION SERVICES FOR COMPANIES IN WASHINGTON STATE THAT ARE THE CONSOLIDATED, SUBSIDIARY, OR COMPONENT ENTITY OF ANOTHER CORPORATE ENTITY REGISTERED IN CANADA

(SB 6256 Senator Conway)

C 224 L 18 Effective date 6/7/2018.

• Provides that chartered professional accountants and firms registered in British Columbia may perform attest and compilation engagements for subsidiaries of Canadian companies operating in Washington without holding a certified public accountant (CPA) or CPA-firm license.

HB 2474 MODIFYING MARIJUANA PRODUCT LABELING REQUIREMENTS

Prime Sponsor: Representative Condotta

(SB 6170 Senator Rivers)

C 43 L 18 Effective date 6/7/2018.

- Requires the label on a marijuana product container sold at retail to include the business or trade name and Unified Business Identifier number of the marijuana producer and processor that produced and processed the marijuana product.
- Provides that the label on a marijuana product container is not required to include information regarding the marijuana retailer.

HB 2517 CONCERNING PENALTIES FOR ALCOHOL MANUFACTURERS WHO HAVE COMMITTED VIOLATIONS AS PART OF ITS ANCILLARY ACTIVITIES

(SB 6239 Senator Saldaña)

C 25 L 18 Effective date 6/7/2018.

- Requires the Liquor and Cannabis Board (LCB) to adopt a schedule of penalties applicable to a licensed alcohol manufacturer who has committed a regulatory violation as part of the licensee's ancillary activities.
- Defines ancillary activities to mean activities relating to serving samples, operating a tasting room, conducting retail sales, serving alcohol under a restaurant license, or serving alcohol with a special occasion license.
- Establishes that the schedule of penalties may not include the suspension, revocation, or cancellation of an alcohol manufacturer's license.

HB 2661 PROTECTING SURVIVORS OF DOMESTIC ASSAULT FROM EMPLOYMENT DISCRIMINATION

C 47 L 18 Effective date 6/7/2018.

- Makes it unlawful for an employer to discriminate against an applicant or employee because the individual is an actual or perceived victim of domestic violence, sexual assault, or stalking.
- Makes it unlawful for an employer to refuse to make a reasonable safety accommodation requested by a victim of domestic violence, sexual assault, or stalking unless the accommodation would impose an undue hardship.

HB 2669 ADDING PART-TIME EMPLOYEES TO STATE CIVIL SERVICE

(SB 6184 Senator Wellman)

C 246 L 18 Effective date 6/7/2018.

Adds part-time employees to state civil service.

HB 2699 EXEMPTING ALCOHOL MANUFACTURERS FROM THE FOOD STORAGE WAREHOUSE LICENSE

Prime Sponsor: Representative Stanford

(SB 6380 Senator Palumbo)

C 96 L 18 Effective date 6/7/2018.

• Exempts certain food storage warehouses used to store alcoholic beverages, under a license issued by the Liquor and Cannabis Board, from also being licensed by the Department of Agriculture.

HB 2702 MAKING TECHNICAL CORRECTIONS TO THE FAMILY AND MEDICAL LEAVE PROGRAM

Prime Sponsor: Representative Robinson

(SB 6338 Senator Keiser)

C 141 L 18 Effective date 6/7/2018.

• Makes several technical and clarifying amendments.

SHB 2703 CLARIFYING HOURS AND WAGES FOR EDUCATION EMPLOYEE COMPENSATION CLAIMS

Prime Sponsor: Representative Sells

(SB 6339 Senator Keiser)

C 97 L 18 Effective date 6/7/2018.

- Changes the requirements for unemployment benefits for educational employees who have multiple employers.
- Modifies the definition of the terms "reasonable assurance" and "contract" with respect to educational employees' continued employment for purposes of unemployment benefits.

HB 2751 CONCERNING THE DEDUCTION OF UNION DUES AND FEES

Prime Sponsor: Representative Stonier

(SB 6296 Senator Saldaña)

C 247 L 18 Effective date 6/7/2018.

• Provides that, if a union security provision exists in a collective bargaining agreement, written authorization from the employee is not required in order for the employer to enforce the union security agreement by deducting the required dues or fees from the employees' pay and transmitting them directly to the union.

SI 940 CONCERNING THE USE OF DEADLY FORCE IN LAW ENFORCEMENT

- Requires that all law enforcement officers in the state receive violence de-escalation training and mental health training.
- Establishes the duty of all law enforcement officers to render first aid to preserve the life of individuals whom the officer comes into contact with while carrying out official duties.
- Establishes a good faith standard, utilizing both an objective and subjective test, to determine whether a law enforcement officer is criminally liable for the use of deadly force.

SB 5213 CONCERNING THE AWARD OF FEES FOR LIMITED LICENSE LEGAL TECHNICIANS IN CERTAIN DOMESTIC VIOLENCE CASES

Prime Sponsor: Senator Wilson

C 84 L 18 Effective date 6/7/2018.

- Applies to court proceedings for domestic violence protection orders.
- Permits the court to award fees incurred by a limited license legal technician.

SSB 5553 PREVENTING SUICIDE BY PERMITTING THE VOLUNTARY WAIVER OF FIREARM RIGHTS

Prime Sponsor: Senator Pedersen

C 145 L 18 Effective date 6/7/2018*.

- Provides a procedure for the voluntary waiver of firearm rights and the revocation of the voluntary waiver.
- Requires entry of a voluntary waiver into the national instant background check system within 24 hours.
- Permits revocation of the voluntary waiver after at least seven days.
- Prohibits transfer of a firearm to a person who has a voluntary waiver in effect.
- Prohibits use of the waiver in any legal proceedings.
- Prohibits requiring a waiver as a condition for employment, services, or benefits.
- Exempts waivers from disclosure under the Public Records Act.
- Requires destruction of any record of the waiver after an individual's firearm rights are restored.

SB 5598 GRANTING RELATIVES, INCLUDING BUT NOT LIMITED TO GRANDPARENTS, THE RIGHT TO SEEK VISITATION WITH A CHILD THROUGH THE COURTS

Prime Sponsor: Senator Pedersen

(HB 2117 Representative Gregerson)

C 183 L 18 Effective date 6/7/2018.

- Permits a non-parent relative who has an ongoing and substantial relationship with a child to request court-ordered visitation if the child risks substantial harm without visitation.
- Requires a court hearing to consider the child's best interests, the risks, and benefits of visitation for the child, and reasons opposing visitation.
- Presumes a fit parent's decision denying visitation is in the child's best interests and does not risk substantial harm to the child, but permits a contrary ruling if evidence is clear and convincing.

SB 5987 CONCERNING PRETRIAL RELEASE PROGRAMS

Prime Sponsor: Senator Padden

(HB 2679 Representative Klippert)

C 276 L 18 Effective date 6/7/2018.

- Allows the imposition of conditions of release for any felony, gross misdemeanor, or misdemeanor case.
- Allows imposing conditions of release to protect the public from harm.
- Clarifies that a pretrial release program is any program in superior, district, or municipal courts.

ESB 5992 **CONCERNING BUMP-FIRE STOCKS.**

Prime Sponsor: Senator Van De Wege

C 7 L 18 Effective date 6/7/2018***.

- Prohibits the manufacture or sale of a bump-fire stock, effective July 1, 2018.
- Prohibits the manufacture, sale, purchase, or possession of a bump-fire stock and declares such a device contraband, effective July 1, 2019.
- Requires that the Washington State Patrol establish a bump-fire stock buy-back program to allow a person to relinquish a bump-fire stock in exchange for \$150.

SB 6027 CONCERNING THE DISCOVERY OF PRIVILEGED HEALTH CARE INFORMATION AND COMMUNICATIONS IN CLAIMS FOR NONECONOMIC DAMAGES UNDER CERTAIN CIVIL RIGHTS LAWS

C 70 L 18 Effective date 6/7/2018.

- Clarifies that a claimant's health is not at issue and no health care privilege is waived by requesting non-economic damages under the Washington Law Against Discrimination, with exceptions.
- Provides a limited waiver of privilege when a claimant alleges a respondent's conduct caused a
 diagnosable injury, or relies on the testimony of a health care provider, or alleges discrimination on the
 basis of a disability.
- Applies the limited waiver only to health care records and communications between the claimant and provider two years prior to the first unlawful act and ending on the last date damages occurred.

ESSB 6037 CONCERNING THE UNIFORM PARENTAGE ACT

Prime Sponsor: Senator Pedersen

C 6 L 18 Effective date 1/1/2019.

- Expands surrogacy rights, duties, and process under the Uniform Parentage Act.
- Authorizes a non-judicial acknowledgement of parentage for intended and presumed parents.
- Revises requirements for documents notice and genetic testing for adjudication of parentage.

SB 6040 ADDRESSING MEETINGS UNDER THE BUSINESS CORPORATIONS ACT

Prime Sponsor: Senator Pedersen

C 55 L 18 Effective date 6/7/2018.

- Allows a business corporation to hold its annual and special shareholder meetings remotely, instead of in-person, unless the articles of incorporation or by-laws prohibit virtual meetings.
- Requires corporations to notify shareholders how to join the meeting, provide all shareholders with a reasonable opportunity to participate and vote during the meeting, and verify a remote participant's identity.

SSB 6051 CONCERNING THE MEDICAID FRAUD CONTROL UNIT

Prime Sponsor: Senator Dhingra

(HB 2273 Representative Goodman)

C 238 L 18 Effective date 6/7/2018.

- Creates a new chapter in the Medicaid statute, authorizing the Medicaid Fraud Control Unit (MFCU) to investigate and prosecute Medicaid provider fraud.
- Authorizes the MFCU to cooperate with local, state, and federal investigations and prosecutions as provided in federal laws.

SB 6053 CONCERNING MEDICAID FRAUD FALSE CLAIMS CIVIL PENALTIES

Prime Sponsor: Senator Keiser

(HB 2326 Representative Ryu)

C 63 L 18 Effective date 6/7/2018.

- Revises the state's Medicaid False Claims Act to include a method for yearly adjustments to the civil penalties to keep them equivalent to the federal Medicaid False Claims Act civil penalties.
- Relieves the attorney general of the requirement to adjust the civil penalties each year through administrative rulemaking.

ESSB 6068 CONCERNING THE APPLICABILITY OF NONDISCLOSURE AGREEMENTS IN CIVIL ACTIONS FOR SEXUAL HARASSMENT OR ASSAULT

Prime Sponsor: Senator Frockt

C 118 L 18 Effective date 6/7/2018.

- Limits the use of nondisclosure agreements (NDA) in civil lawsuits or administrative actions related to sexual harassment or sexual assault.
- Clarifies that NDAs include any arbitration agreement or decision.
- Permits the discovery of past instances of sexual harassment or sexual assault in a civil lawsuit notwithstanding any NDA.
- Permits witness testimony of past instances of sexual harassment or sexual assault in a civil lawsuit notwithstanding any NDA.
- Requires the court to enter orders to protect the identity of any victim, upon motion of any party supported by affidavit or declaration.

SB 6188 ENCOURAGING FAIRNESS IN DISCIPLINARY ACTIONS OF PEACE OFFICERS

Prime Sponsor: Senator Dhingra

(HB 2532 Representative Sells)

C 265 L 18 Effective date 6/7/2018.

- Prohibits disciplinary or adverse personnel action against a law enforcement officer solely because: (1) the officer's name appears on a prosecutor's recurring witness list; or (2) the officer's name may be subject to disclosure pursuant to the holding in *Brady v. Maryland*.
- Allows disciplinary action for any underlying conduct that resulted in the officer being placed on the list.

SB 6298 ADDING DOMESTIC VIOLENCE HARASSMENT TO THE LIST OF OFFENSES FOR WHICH A PERSON IS PROHIBITED FROM POSSESSING A FIREARM

Prime Sponsor: Senator Dhingra

C 234 L 18 Effective date 6/7/2018.

• Adds the crime of harassment to the list of domestic violence misdemeanor convictions that prohibit possession of a firearm.

SSB 6334 CONCERNING CHILD SUPPORT, BUT ONLY INCLUDING A PARENT'S OBLIGATION TO PROVIDE MEDICAL SUPPORT, USE OF ELECTRONIC FUNDS TRANSFERS, NOTICE OF NONCOMPLIANCE, ADOPTION OF THE ECONOMIC TABLE RECOMMENDED BY THE CHILD SUPPORT WORK GROUP, AND REFERENCES TO THE FEDERAL POVERTY LEVEL IN SELF-SUPPORT RESERVE LIMITATIONS

Prime Sponsor: Senator Dhingra

(HB 2405 Representative Goodman)

C 150 L 18 Effective date 6/7/2018*.

- Revises provisions governing a parent's obligation to provide medical support for a child under a child support order, including allowing a parent to meet the obligation by enrolling the child in public health care coverage.
- Requires an employer or other business that has received an income withholding order from the Department of Social and Health Services for payment to the Washington State support registry, to remit payments through electronic funds transfer when certain conditions apply.
- Authorizes the Division of Child Support (DCS) to issue a notice of noncompliance to a business, employer, or payroll processor if DCS believes the parent is not complying with support payment conditions.
- Adopts a new economic table for child support obligations that no longer differentiates amounts based on a child's age.
- Clarifies the self-support reserve limitation on the amount of child support ordered.

SB 6408 REGULATING BODY WORN CAMERAS

(HB 2893 Representative Hansen)

C 285 L 18 Effective date 6/7/2018.

- Removes expiration dates making current requirements and the Public Records Act provisions governing body worn cameras permanent and applicable to all law enforcement and corrections agencies deploying body worn cameras.
- Adds a definition of intimate images as it relates to body worn camera recordings.
- Clarifies records retention requirements for body worn camera recordings.

SHB 1022 ENHANCING CRIME VICTIM PARTICIPATION IN THE CRIMINAL JUSTICE SYSTEM PROCESS

Prime Sponsor: Representative MacEwen
C 86 L 18 Effective date 6/7/2018.

- Establishes the Safety and Access for Immigrant Victims Act, requiring law enforcement and other agencies to complete certifications for U or T nonimmigrant visa requests from immigrant crime victims, in a timely manner.
- Requires the Criminal Justice Training Commission to develop minimum standards for a course of study on U and T nonimmigrant visas and other legal protections for immigrant survivors of criminal activity.

HB 1056 CONCERNING CONSUMER PROTECTIONS FOR MILITARY SERVICE MEMBERS ON ACTIVE DUTY

Prime Sponsor: Representative Kilduff

(SB 5041 Senator Baumgartner)

C 197 L 18 Effective date 6/7/2018.

- Changes the definition of service member for purposes of the Washington Service Members' Civil Relief Act (WSCRA).
- Allows the Washington Attorney General to recover costs and reasonable attorneys' fees in an action brought to enforce the WSCRA.
- Provides a mechanism in the WSCRA for the termination, suspension, and reinstatement of certain telecommunication, Internet, health studio, and television service contracts.

HB 1058 CHANGING PROVISIONS RELATING TO COURT-ORDERED RESTITUTION IN CERTAIN CRIMINAL CASES

Prime Sponsor: Representative MacEwen
C 123 L 18 Effective date 6/7/2018.

• Prohibits the court from postponing the commencement of victim restitution payments until after the offender is released from confinement.

EHB 1128 CONCERNING CIVIL ARBITRATION

Prime Sponsor: Representative Shea

C 36 L 18 Effective date 9/1/2018.

- Removes all references to the word mandatory throughout the mandatory arbitration laws, replacing it with civil in some instances.
- Increases the maximum arbitration limit up to \$100,000 if approved by the superior court of a county by at least two thirds of judges.
- Adopts rules for arbitrator's qualifications, arbitration hearings, discovery, and appeal.
- Increases the arbitration filing fee from \$220 to \$250, and the trial de novo filing fee from \$250 to \$400.

SHB 1524 INCREASING SUCCESS IN THERAPEUTIC COURTS

Prime Sponsor: Representative Kloba
C 205 L 18 Effective date 6/7/2018.

- Revises the recovery support and treatment services that may be paid from the Criminal Justice Treatment Account (Account) for an individual drug court participant's substance use treatment program.
- Clarifies the process for the state treasurer's fund transfer from the General Fund to the Account.

E2SHB 1783 CONCERNING LEGAL FINANCIAL OBLIGATIONS

Prime Sponsor: Representative Holy

C 269 L 18 Effective date 6/7/2018**.

- Eliminates interest accrual on the non-restitution portions of legal financial obligations (LFOs).
- Provides that a court may not impose costs on a defendant who is indigent at the time of sentencing.
- Establishes provisions governing payment plans and priority of payment of LFOs.
- Addresses actions a court may take in sanction proceedings for failure to pay LFOs where the offender's failure to pay is not willful and establishes standards for what constitutes willful failure to pay.
- Provides that 100 percent of the crime victim penalty assessment must be deposited into a fund for crime victim and witness programs.
- Provides that the DNA database fee is not mandatory if the offender's DNA has been collected as a result of a prior conviction.

EHB 2097 LIMITING DISCLOSURE OF INFORMATION ABOUT THE RELIGIOUS AFFILIATION OF INDIVIDUALS

Prime Sponsor: Representative Stanford

(SB 5828 Senator Palumbo)

C 303 L 18 Partial Veto Effective date 6/7/2018.

- Limits an employer from requiring disclosure of an employee's religious affiliation making such requirements an unfair practice violating Washington's Law Against Discrimination.
- Prohibits a public agency and its personnel from using the agency's resources to disclose an individual's religious affiliation to the federal government; or compiling information regarding individual religious beliefs, national origin, or ethnicity for immigration or law enforcement purposes.
- Restricts a local or state law enforcement agency from collecting or using information about an individual's religious affiliation, with limited exceptions.
- Exempts personal information about an individual's religious affiliation from disclosure under the Public Records Act.

Partial Veto: Vetoed section:

Codifying the bill as a new chapter in Title 42 RCW.

SHB 2308 CONCERNING CIVIL LEGAL AID

Prime Sponsor: Representative Jinkins

(SB 6041 Senator Pedersen)

- C 21 L 18 Effective date 6/7/2018.
- Requires the Office of Civil Legal Aid to periodically assess the most prevalent civil legal problems experienced by low-income people in the state.
- Updates authorized areas of legal representation for civil legal aid funding to be consistent with the greatest areas of need identified by the civil legal needs study.

HB 2368 MAKING TECHNICAL CORRECTIONS AND REMOVING OBSOLETE LANGUAGE FROM THE REVISED CODE OF WASHINGTON PURSUANT TO RCW 1.08.025

Prime Sponsor: Representative Goodman

C 22 L 18 Effective date 6/7/2018.

• Removes obsolete language in various sections of the Revised Code of Washington and corrects technical errors.

SHB 2398 CONCERNING JURY SELECTION

Prime Sponsor: Representative Kilduff

C 23 L 18 Effective date 6/7/2018.

- Expands existing prohibitions for excluding a person from jury service to conform with the Washington Law Against Discrimination.
- Prohibits excluding a citizen from jury service based on race, creed, color, national origin, sex, honorably discharged veteran or military status, sexual orientation, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a person with a disability.
- Maintains the duty of a judge to excuse a juror, or the right of any party to make challenges to individual jurors who are not qualified or not competent, due to bias, prejudice, indifference, inattention or any physical or mental defect.

SHB 2514 REGARDING DISCRIMINATORY PROVISIONS FOUND IN WRITTEN INSTRUMENTS RELATED TO REAL PROPERTY

Prime Sponsor: Representative Kilduff

C 65 L 18 Effective date 6/7/2018*.

- Authorizes a non-judicial alternative to striking discriminatory language from real property written instruments.
- Permits the owner of real property and others to record a document modifying restrictive covenants with the county auditor, striking provisions that are void and unenforceable under the Washington Law Against Discrimination (WLAD).
- Prohibits charging filing or recording fees for documents that modify covenants to strike discriminatory language.
- Allows homeowner associations to remove all provisions in governing documents that are void under WLAD.

EHB 2519 CONCERNING CONCEALED PISTOL LICENSE ELIGIBILITY REQUIREMENTS

Prime Sponsor: Representative Lovick

C 226 L 18 Effective date 6/7/2018.

- Requires a law enforcement agency to ensure a person meets the eligibility requirements for a concealed pistol license (CPL) prior to returning a CPL that has been surrendered to law enforcement.
- Adds extreme risk protection orders, sexual assault protection orders, and stalking protection orders to the current provision making an applicant ineligible for a CPL if the applicant is subject to a court order or injunction regarding firearms under various protection, restraining, and no-contact orders.
- Allows a law enforcement agency to take a photo of an applicant for a concealed pistol license and print the licensee's photo on the face of the license.

HB 2611 CONCERNING THE PRIVILEGE FOR PEER SUPPORT GROUP COUNSELORS

Prime Sponsor: Representative Barkis

C 165 L 18 Effective date 6/7/2018.

• Establishes a testimonial privilege for certain communications made by a limited authority law enforcement officer to a peer support group counselor while receiving counseling.

SHB 2752 CONCERNING ISSUANCE OF SEARCH WARRANTS BY DISTRICT AND MUNICIPAL COURT JUDGES

Prime Sponsor: Representative Stanford

C 50 L 18 Effective date 6/7/2018.

- Authorizes municipal court or district court judges who serve in courts with jurisdiction over all or parts of multiple counties, to issue a search warrant related to an alleged crime occurring in any of the counties within the court's jurisdiction.
- Authorizes execution of these search warrants anywhere within the state.

EHB 2777 IMPROVING AND UPDATING ADMINISTRATIVE PROVISIONS RELATED TO THE BOARD OF TAX APPEALS

Prime Sponsor: Representative Jinkins

C 174 L 18 Partial Veto Effective date 6/7/2018.

- Requires qualifications, training, and duties for members of the Board of Tax Appeals (Board) and tax referees.
- Requires publication of orders and a decision with precedential value on a public website.
- Provides an informal and voluntary mediation with confidentiality.
- Requires reporting on the number of appeals and the development of a plan for pending appeals.

Partial Veto: Vetoed sections:

- Requiring the Board to maintain five tax referees.
- Mandating that the Board hold hearings in Spokane and King counties.
- Requiring the Board to make its orders and decisions of precedential value available online.
- Authorizing settlement conferences and providing a mediation process.
- Authorizing the award of attorney fees and expenses for qualified parties.

SHB 2822 CONCERNING SERVICE ANIMALS

Prime Sponsor: Representative Steele

C 176 L 18 Effective date 1/1/2019.

- Limits service animals under the public accommodation provisions of Washington's Law Against Discrimination to dogs and miniature horses specifically trained for tasks related to an individual's disability.
- Retains a requirement for reasonable modifications to public accommodations to permit access for miniature horse service animals.
- Limits inquiry by a public accommodation staff person or an investigating officer to determine whether a person is misrepresenting an animal as a service animal.
- Establishes the civil infraction of misrepresenting an animal as a service animal.

HB 2892 ESTABLISHING THE MENTAL HEALTH FIELD RESPONSE TEAMS PROGRAM

Prime Sponsor: Representative Lovick

C 142 L 18 Effective date 6/7/2018.

- Creates a new grant-funded program based on local partnerships between law enforcement agencies and mental health providers, subject to appropriation.
- Designates the Washington Association of Sheriffs and Police Chiefs (WASPC) as the program's implementing agency in consultation with managed care systems, behavioral health organizations, the Department of Social and Health Services (DSHS), and other entities.
