# **Behavioral Health System Capacity**

The state operating budget, in coordination with the state capital budget, has included numerous efforts designed to increase the inpatient capacity of the behavioral health system. Examples include the Olympic Heritage Behavioral Health facility, additional forensic beds at the state hospitals, capacity at Maple Lane, and the University of Washington teaching hospital. Additionally, the operating budget has funded numerous efforts to divert clients from inpatient care by providing increased services.

The Committee will receive an update on inpatient capacity, by geographic area, as well as on efforts to serve clients in other appropriate care settings. (One work session)

#### Child Care Access and Availability

The Working Connections Child Care (WCCC) program, a program funded in the operating budget, helps eligible families pay for child care while they work, attend job training, or participate in educational programs. Eligibility is determined by household income, though some families may be categorically eligible for WCCC. The WCCC program pays a monthly subsidy payment directly to the child care provider based on child age, geographic location, and other factors. Eligible families also make a monthly copayment directly to the provider, based on household income.

The state operating budget has included numerous efforts designed to facilitate the access, affordability, and availability of child care. The Committee will receive an update on the availability of child care including how additional child care funding contained in the operating budget has impacted affordability and availability of services. #### 2025 Session Budget Preview

The Committee will receive an update on the budget outlook after the September and November revenue forecasts and estimated maintenance level changes. The Committee will also receive a preview of budget related items that may come before the Legislature in the 2025 session. (One work session)

# CIVIL RIGHTS & JUDICIARY COMMITTEE WORKPLAN

#### **Court Innovation Programs**

The Committee will hold a work session on court innovation programs, including behavioral health, equity and access, family and youth justice, Supreme Court commissions, and the Washington State Center for Court Research. (One work session)

#### **Tribal Courts**

The Committee will hold a work session on tribal courts and an overview of how they operate across the state. The Committee intends to invite relevant state agencies, subject matter experts, and other stakeholders to present on these topics. (One work session)

#### Trueblood Lawsuit Update

The Committee will hold a work session on issues relating to the *Trueblood* lawsuit, which addresses excessive wait times for competency evaluation and restoration services for in-jail criminal defendants. The work session will include an update from the Department of Social and Health Services and the Health Care Authority on the status of the lawsuit, compliance with and implementation of the contempt settlement agreement, and implementation of programs geared to providing timely competency evaluation and restoration services for criminal defendants. # Office of Public Defense Program for Persons Committed Following Acquittal by Reason of Insanity

Legislation enacted in 2023 gave the Office of Public Defense (OPD) responsibility for administering all statefunded services related to representation of indigent persons who are found not guilty by reason of insanity and committed to state psychiatric care. The Committee will receive an update from the OPD on implementation of the program for post-commitment representation of persons acquitted by reason of insanity. (One work session)

#### **Crime Victims' Rights and Resources**

The Committee will examine the current rights and resources available to crime victims, survivors of victims, and witnesses of crimes, and explore ways to improve such supports, including by empowering the voices of victims through access to victim advocates, providing benefits to victims through the Department of Labor & Industries' Crime Victims Compensation Program, and ensuring that the statutory and constitutional rights of victims are upheld in key judicial proceedings. # Rethinking Misdemeanors: Dismissals, Diversions, and Other Alternatives to Prosecution

The Committee will evaluate a range of topics related to the filing and disposition of misdemeanor charges, including rates of misdemeanor prosecutions and dismissals in the state, use of diversions and other alternative methods to resolve cases, trends in the demographics of defendants and outcomes for vulnerable populations, and issues with criminalizing conduct rooted in behavioral health crises. (One work session)

#### Felony Sentencing Reform

The Committee will review the state's current adult felony sentencing laws and consider policy recommendations related to: reducing complexities and errors in sentencing; addressing racial disparities in the length of sentences; expanding the availability of intermediate sanctions and access to rehabilitative and reintegration services and programs; improving the effectiveness of the criminal legal system; and promoting community safety. (One work session)

#### **Recent Crime Trends**

The Committee will receive a briefing on the most recent crime statistics from entities that collect crimerelated data and study discernable trends in the incidence and types of crime. (One work session)

# Paid Family and Medical Leave Program – Implementation and Service Update

# Financial Aid and the Free Application for Federal Student Aid (FAFSA)

The Committee will receive a briefing from the State Board for Community and Technical Colleges and the Council of Presidents on the U.S. Department of Education's roll-out of the new, simplified FAFSA. One area of focus will include how institutions have responded to the challenges and delays of the launch of the simplified FAFSA, and the resulting impacts on students and families such as enrollment rates. # Student Learning, Completion, and Employment Outcomes

The Committee will receive a briefing on institutional data regarding institutional characteristics, enrollment, financial aid, costs, student debt, and student outcomes such as earnings and employment for college and university graduates by degree level and degree major. The briefing will also include how institutions collect these data and assist students in completing their degrees and with employment outcomes. (One work session)

# Eastern Washington University's Educational Specialist in School Psychology (EdS) Distance-learning Program

The Committee will receive a briefing from Eastern Washington University on its EdS Distance-learning Program, which is delivered primarily online and was the first online School Psychology program to be accredited by the National Association of School Psychologists. The presentation will cover student demographics, engagement, and employment outcome data. (One work session)

#### **Credential Transparency**

With a presentation from the State Board for Community and Technical Colleges, the Committee will evaluate credential transparency data integration across education and workforce data systems, such as online registries that provide users information to understand, evaluate, and access essential information about educational and occupational credentials, including diplomas, certificates, digital badges, certifications, licenses, apprenticeships, military training, and degrees. The Committee will also explore how credential transparency impacts the educational, career, and economic momentum of Washingtonians. (One work session)

# Cannabis, Tobacco, and Vapor Product Policy and Regulatory Update

The Committee will receive an update from state agencies including the Liquor and Cannabis Board (LCB) regarding current and future cannabis, tobacco, and vapor product policy and regulatory issues. This will include examining: (1) implementation of prior enacted legislation related to social equity in the cannabis industry, the regulation of products containing tetrahydrocannabinol (THC), and the cannabis excise tax exemption for medical cannabis patients and designated providers; (2) the response to dichlorodiphenyldichloroethylene (DDE) contamination at certain licensed cannabis production facilities in north central Washington; (3) the use of the Cannabis Central Reporting System; (4) the status of prevention programs for tobacco, vapor products, and cannabis; and (5) new and emerging issues related to licensed cannabis production, processing, and sales, and the sale of products containing THC. (One work session)

# Washington State Patrol Cannabis Enforcement Update

The Committee will receive an update from the Washington State Patrol (WSP) regarding the WSP's enforcement of illegal cannabis production, processing, and sales, and the work of the WSP's drug enforcement task forces funded through the Dedicated Cannabis Account. (One work session)

# Washington State Institute for Public Policy Reports on Cannabis Legalization

The Committee will receive an update from the Washington State Institute for Public Policy on cost-benefit evaluations of the implementation of Initiative 502 (2012). The committee will examine the findings in these evaluations, including the following reports completed in 2023: (1) *Licensed Non-Medical Cannabis Retail Access and High School Outcomes in Washington State*; (2) *A 10-Year Review of Non-Medical Cannabis Policy, Revenues, and Expenditures*; and (3) *Initiative 502 and Cannabis-Related Public Health and Safety Outcomes: Third Required Report*. (One work session)

#### **Problem Gambling**

The Committee will monitor problem gambling treatment and prevention programs in Washington, evaluate the implementation and impact of recently enacted legislation (E2SSB 5634 (2023)) relating to problem gambling policy and funding, examine the use and effectiveness of self-exclusion programs, and monitor current and emerging gaming issues impacting problem gambling and gambling disorder. The Committee will engage with state agencies, tribes, the Washington Indian Gaming Association, and the Evergreen Council on Problem Gambling. (One work session)

#### **Increasing Voter Turnout**

The state has taken many steps to increase voter turnout over the past several sessions, but there are still barriers and accessibility issues that prevent some voting-age citizens from casting a ballot. The Committee will invite experts in elections and voting rights to discuss which recent election accessibility policies have led to increased turnout, as well as further steps that the Legislature can consider taking to further increase voter turnout in state and local elections. (One work session)

#### **Campaign Finance Enforcement**

The Committee will invite the Public Disclosure Commission to discuss the agency's processes for enforcing and providing guidance about campaign finance disclosure requirements. (One work session)

#### **Special Purpose District Elections**

The Committee will invite the Washington State Institute for Public Policy to discuss its June 2024 report about Conservation District elections and the election code in Title 29A RCW. The Committee will also invite experts in elections and voting rights to discuss steps that the Legislature can consider taking to improve special district elections for districts that do not hold elections under Title 29A RCW. (One work session)

# TRANSPORTATION COMMITTEE WORKPLAN

#### **Transportation Safety**

The Committee will receive an update on current and planned rules of the road enforcement efforts to address traffic safety by the Washington State Traffic Safety Commission and the Washington State Patrol. Areas of focus will include:

- the use of funding by the Traffic Safety Commission directed towards enforcement efforts at the state and local level;
- plans for the use of increased federal and state funding, such as new federal funding for enforcement efforts and new state funding for DUI enforcement grants and an ignition interlock compliance pilot;
- an overview of the impact of law enforcement staffing shortages on enforcement, the Washington State Patrol's use of performance goals in this area, and the role of emphasis patrols on enforcement activities; and
- the impact of state funding on traffic safety from the perspective of one or more local law enforcement entities.

(One work session)

#### **Active Transportation Activities**

The Committee will be updated on the implementation of new programs funded largely by Climate Commitment Act revenues to support active transportation at the local level. Updates will include information about outreach and technical assistance to communities that have not historically benefited from transportation investments. These programs include: a statewide school-based bicycle education program; the Sandy Williams Connecting Communities program to fund local projects which reconnect communities that have been bifurcated by state highways; a grant program to support local jurisdictions' network-wide traffic conflict screening programs in intersections with disproportionate numbers of injuries to active transportation users; an e-bike rebate program; assistance to local jurisdictions in addressing emergent issues related to safety for pedestrians and bicyclists; and support to develop a plan to establish cycle highways to connect population centers. (One work session)

#### Public Transportation: Update

The Committee will receive updates on the state of public transportation in Washington, including presentations from the Washington State Department of Transportation, local transit agencies, and transportation stakeholders. Topics covered may include current challenges and opportunities in operations, zero-emissions transition progress, and service levels and ridership. Updates will also be provided on the awarding and expenditures of Climate Commitment Act funds. (One work session)
